**Sub:** Commemorating 150<sup>th</sup> birth anniversary of Mahatma Gandhi for a period of two years from 2<sup>nd</sup> October 2018 to 2<sup>nd</sup> October 2020 – instructions regarding.

The Government of India has informed that they are commemorating 150<sup>th</sup> birth anniversary of Mahatma Gandhi for a period of two years from 2<sup>nd</sup> October 2018 to 2<sup>nd</sup> October 2020 at National and International Level. The Government of the State of Haryana endorses and decides to be a partner in the said decision/efforts by the Government of India.

2. Accordingly, it is directed that, unless there are justified reasons not to do so, all organs of the Government of Haryana being supported through the resources drawn from the Consolidated Fund of Haryana and all the Boards/Corporations/Public Sector Undertakings/Local or other authorities wholly or substantially owned or controlled by the Government of Haryana shall, in addition to such other lawful instructions issued in this regard, follow/adhere to/implement the following during the prescribed duration:

- i. They shall Logo Brand in all the Government/their respective Website; E-mails, Government/their respective stationery, Government/their respective Calendars and Diaries, Government/their respective advertisement and publicity materials and digital signatures, Government of their respective Posters and Banners and, as the case may be, in any other medium deemed appropriate, the Logo Branding as approved and propagated by the Government of India.
  - ii. Such Logo Branding may appear on all the activities undertaken after 2<sup>nd</sup> October, 2018 and must appear on all such material/instruments as have been elaborated above.
  - iii. These shall apply to all such printing works executed at a private press (irrespective of the manner in which it has been authorized). In all such cases where such a provision has not been included in the respective contract, additions to this effect of compliance must be included suitably and promptly.
  - iv. For all other instruments, other than the 'printing works executed at a private press', the spirit of the instructions in sub-para (iii) above shall apply *mutatis mutandi*.
3. In all such cases where it is felt that there are justified reasons not to adhere to in accordance with the instructions incorporated under para 2 above, full justification supporting such limitation must be communicated at the earliest to the Controller of Printing & Stationery for causing them to be appreciated by the Government.
4. Designs of approved Logo with colour guide are available on the web-site <http://hindi.gov.in/download.html> for download: -
- i. Logo in original form (Main Logo)
  - ii. Logo for use in single colour (for use in black and white)
  - iii. Logo in reverse form with light/bright background
  - iv. Logo in reverse form with dark background

5. It is requested in earnest to instruct all agencies, organizations, etc, under the control of the State of Haryana to use these Logos for the intended/directed purpose during the commemoration period on all such materials that are included in these instructions.
6. These may be brought to the notice/information of all concerned for appropriate compliance.
